## 2. Minutes of last meeting

The minutes of the meeting held on 3<sup>rd</sup> April 2023 were proposed as accurate by KO and seconded by JW.

## 3. Matters arising (Not on agenda)

Member of the public raised that some details were omitted minutes of the last meeting re Ring of the Loch car parking, that change of use would need to be applied for as this is currently a picnic site – **Action KI to amend minutes. Action: AR to refer back to EYCDC** 

Tour of the Borders – Question raised over when the next TOTB event will be – up for discussion at the next CC Meeting.

Community Council Vacancy – Fiona Hewson has now resigned from the Community Council which leaves a vacancy. The Community Council has recently gone through the election process last year (this process can only happen every 4 years), we do have the option to co-opt members should we fall below the required number.

Community Council may consider possible co-option of new members in the future.

## 6. Financial Report

- MA reported a bank balance of £22,309.93 at 1 June 2023. We received our 2022 allocation from the Langhope Rig Community Benefit Fund B in May, which was £9.5K, so we have a very healthy bank balance.
- SBC has not yet made a decision about whether the paths maintenance grant that has
  operated in previous years would be available again this year. SBC will inform
  community councils once the decision is made.
- MA has still to investigate opening a savings account with RBS. Action MA

## 8. Ettrick Valley Flooding

Councillor ET-N previously stated works were to be carried out but no date confirmed.

AR strongly recommended local community was consulted before works carried out to ensure worthy. — Action ET-N to follow up and ask SEPA to attend next E & Y CC meeting

No emergency plan in place at the moment, this pertains to Yarrow Valley also.

General feeling is that dredging small areas of the river may alleviate flooding - Action AR to write to SBC to suggest specific meeting to discuss with locals and landowners for best way forward.

Action – ET-N to email Connor Price who has already undertaken Hydrology survey which included Ettrick Valley

- Concerns raised re the conflict of interest around Community Council members and interested parties of the wind farm proposal
- Opportunities to consult on the meteorological masts in January 2022 was not undertaken. Community had no say. Failure to deal with conflict of interest issues.
